Overview

In this lesson, students will use primary sources that are relatable to their age to see the issues of child labor within North Carolina Textile Mills. Students will recognize the impact that Child Labor had on the state, and how these issues address the changes and developments of Child Labor Laws in North Carolina.

The introduct	tion to this lesson will activate background knowledge and provide a basic overview of lls in NC.			
Step 1	 Two-column notes while viewing background video. Students should divide their paper into two columns (right side labeled new knowledge, left side labeled questions) Teacher should play video on the projector, or have students view video with headphones at their desk - https://www.youtube.com/watch?v=rYKSrjfQfu8 Students should complete notes individually while viewing 			
Step 2	 Think-Pair-Share Teacher poses an essential question to encourage reflective processing: What were the impacts of the textile mills in NC? Students should look back at their notes and construct a brief answer to this question, which they will then share with a neighbor. As partners, they will refine their ideas to share with the whole group. Teacher will compose an Inquiry chart with the essential question at the top, and class responses in the left column below the question. Teacher will ask for volunteers to share questions they noted during the video or questions that were stimulated during the partner conversations. The class will then brainstorm a list of possible sources they might use to answer these questions. 			
Formative	Teacher can use the inquiry chart as a record of students' initial understanding,			
Assessment	questions, and how to guide the next series of lessons.			

The Gallery Walk will help students specifically examine child labor within the textile mills and								
make connections between children of the past and their own experiences								
	Teacher will post each of the primary source images in the center of a large poster							
Step 1	paper, and then assign student groups to each poster.							
Step 2	Groups will spend about 5 minutes at each poster. While there, they should make 1 observation, 1 inference and ask 1 question which they will individually record on their analysis guide chart (see below). Then they will add two tweets to the poster (one tweet that reflects how the child in the image feels, and a second tweet that reflects how they feel looking at this image now).

Formative Assessment	When groups return to their original poster, they should write a notecard synthesis of the tweets answering the following question: "How are the experiences of the child(ren) in this image similar or different than your own? How does this make you feel about child labor in the textile mills?"							

Informative Poster activity will allow students to glean information from the images, reflect on the dangers of child labor, and then express these views to an audience through infographics.					
Step 1:	Return to the essential question in the first activity, and brainstorm pros and cons as a class. Is there any new information that can be added after close examination of the images?				
Step 2	Assign partners and introduce students to the Canva tool for building infographics.				
Step 3	Student partners will work together to create an infographic explaining why child				
	labor should not be allowed.				
Summative	Infographics will be graded based on the following criteria:

	The information clearly represents the negative views on child labor				

Post infographics in a classroom display in order to refer back to as you move through more information in this unit. See what other information can be added, or if student opinions change and they can make an argument as to why child labor was a good thing at the time.

Extension Activities

- 1) Students can interview classmates about the work they do at home. Then create a video of then and now expressing the views on child labor in both time periods.
- 2) Student groups can research the person behind the picture http://www.historyplace.com/unitedstates/childlabor/. Then write a narrative based on the image and other biographic information they were able to gather.
